

CAMP SCHOLLER CAMPING RULES AND POLICIES Effective April 19-29, 2025

All campers staying in Camp Scholler, which is a privately-owned campground owned and operated by Experimental Aircraft Association, Inc. ("EAA"), during the NFL Draft are subject to, and must follow, the Camping Rules and Policies, set forth below:

Campsite Reservations and Credentials

- Only water and electric campsites can be reserved for use during the NFL Draft.
- All campsites are reserved on a first-paid, first-served basis.
- Campsites may be purchased by going online at EAA.org/Camping/Football or by going to the Camper Registration building during open hours. Campsites cannot be reserved or purchased over the phone.
- Once purchased, a campsite tag will be placed on the applicable campsite to indicate the campsite has been reserved and is no longer available.
- Upon arrival, individuals must check-in at the Camper Registration building to receive their camping credentials.
- Camping credentials must be visibly displayed at all times on the camping unit and motor vehicle or motorcycles, if any. EAA security will periodically monitor the campsites to verify that proper camping credentials are displayed.
- Additional vehicle parking passes for the overflow parking lot may be purchased online or onsite at the Camper Registration building.
- Camping credentials and campsites may not be transferred or sold from one individual to another individual. Abandoned water and electric campsites may only be resold by EAA.
- Each water and electric campsite is serviced by one power pedestal. Plugging into any EAA building, facility or other campsite to run power is strictly prohibited.

Trailers, Vehicles and Tents

- No more than one (1) travel trailer, truck camper or recreational vehicle is allowed per campsite. Truck campers or recreational vehicles pulling a trailer are treated as one (1) single unit.
- No more than one (1) motor vehicle, or two (2) motorcycles, are allowed per campsite. Unauthorized or additional vehicles placed or parked in the campsite will be towed.
- The number of tents allowed depends on the sizes of the tents. Call EAA in advance if you are considering bringing multiple tents.

Camping Party - Minimum Age and Maximum Occupants

- No more than six (6) persons may stay overnight at each campsite, regardless of age.
- The individual placing the reservation must be at least eighteen (18) years old at the time the reservation is made. The person to whom the campsite is registered must be, and remain, part of the camping party at the campsite for the entirety of the stay and will be held responsible if any violations occur.



Checking In, Checking Out and Gate Hours

- You may check into your campsite any time after 9:00 a.m. on your reservation start date.
- You must check out of your campsite before 12:00 p.m. on the last day of your reservation. Campers leaving after 12:00 p.m. will be charged for that day. There is no grace period.
- Access to Camp Scholler will be provided from April 19, 2025 to April 29, 2025 from two separate entrances as follows (hours are subject to change):
 - o Camp Scholler Camper Registration Gate: 24 hours/day
 - o West Gate: 6:00 a.m. to 6:00 p.m.

Quiet Hours and Noise

- Quiet hours will be enforced from 12:00 a.m. to 7:00 a.m. During these hours campers are expected to be quiet and especially respectful of other campers and should turn down music and use low voices.
- At no time may the noise on a campsite create a disturbance or interfere, in any manner, with other people's enjoyment of the campground.

Garbage, Wastewater and Dump Stations

- Campsites must be left and restored to the same condition that they were in when the camping group arrived, normal wear and tear excluded.
- All garbage must be removed from the campsite daily and all waste must be deposited in appropriate receptacles.
- Dish and handwashing water must be disposed of at the sanitary dump station or in the campground toilets. It is against health and safety rules to dump "gray water" on the ground.
- Sewage must be disposed of at the sanitary dump station.

Campfires

- Campfires are allowed in firepits or existing fire rings and must never be left unattended.
- The Wisconsin Department of Natural Resources requests that all campers obtain firewood at or within a 10-mile radius of Camp Scholler or that campers purchase state-certified firewood.
- Only wood should be put into the fire garbage, plastic, glass, cans and other items should not be burned.
- Fires need to be kept small and logs larger than the firepit area should not be burned.
- Campfires must be doused with water and extinguished completely when not attended.
- If the fire danger is high, as determined by the Wisconsin DNR, then fires may be prohibited.
- Campers are responsible for cleaning up after a campfire and for any damages caused by an uncontrolled or unattended fire.

Special Events, Live Entertainment, Commercial Operations and Advertising

- Campsites purchased to place non-camping units (i.e. used as a central meeting location or a lounge area) must be used in a way that only supports those camping in Camp Scholler.
- Events that require catering, security, or hosted alcohol, and/or are by invitation to the general public are not permitted.
- Live entertainment, such as live bands or disc jockeys, is not permitted in Camp Scholler.
- No commercial operations are permitted in Camp Scholler. Advertising, exhibiting, demonstrating goods or services and/or soliciting, of any kind, is strictly prohibited.



Prohibited Items

The following items are prohibited in Camp Scholler:

- Firearms (whether carried openly or concealed) and weapons that could be considered dangerous.
- Fireworks, pyrotechnics and explosives.
- Illegal drugs and/or drug paraphernalia.
- Flying objects, i.e. radio-controlled aircraft and objects, Chinese lanterns, and unmanned aerial vehicles a/k/a drones. This prohibition does not include frisbees, footballs, baseballs and other sporting items and equipment.
- Anything that can be considered, by law or statute, as illegal or contraband.

Vehicles and Personal Transportation

- Unlicensed motorized vehicles including motorbikes, motor scooters, or motorcycles are prohibited on Camp Scholler roadways.
- A valid driver's license is required to drive motor vehicles in Camp Scholler. This does not include golf carts, ATVs or UTVs.
- Vehicle speed limit is a <u>maximum of 10 MPH</u> for all vehicles including, but not limited to, automobiles, motorcycles, golf carts, ATVs, UTVs, and mopeds.
- Vehicles, including automobiles, motorcycles, golf carts, ATVs, UTVs and mopeds, may only be
 driven on roadways and must be equipped with lights to be driven at night. Cutting through
 lots, undeveloped areas and/or empty campsites is strictly prohibited.
- Bicycles (including e-bicycles) and personal transportation devices, such as rollerblades, hoverboards, scooters and Segways, are allowed in Camp Scholler.

<u>Pets</u>

Pets are allowed in Camp Scholler, but are not allowed in buildings, playgrounds or picnic shelters. While EAA strongly recommends that alternate arrangements be made for your pet, if you decide to bring your pet, the following guidelines must be adhered to for everyone's enjoyment and safety:

- A maximum of three (3) pets are allowed per campsite.
- Pets must be on a leash that is no longer than eight feet (8') long, or otherwise physically restrained, at all times.
- Owners are responsible for cleaning up after their pets and promptly disposing of waste in trash receptacles.
- Pets left unattended must be kept in a well-ventilated camping unit. The Winnebago County Sheriff's Department or other local animal control authority will be called to respond to pets that are barking excessively while unattended or that appear to be in distress.
- Loose pets will be seized and turned over to the Winnebago County Sheriff's Department or other local animal control authority or shelter.
- Pets must be kept under control at all times and should not interfere with other individuals' enjoyment of Camp Scholler.
- Pets that bark excessively, growl, exhibit aggressive behaviors, create a public nuisance or otherwise cause a disturbance are prohibited.



ADA Accessibility

- ADA accessible restrooms are available at the campground shower facilities.
- If reserving an ADA accessible campsite, one member of the group for the campsite must be a qualified individual with a disability that relates to the need for an accessible space. EAA reserves the right to remove groups from an ADA accessible campsite that cannot show that at least one individual camping at the campsite is a qualified individual with a disability under state or federal law.

Waiver of Liability, Assumption of Risk and Indemnification

 At the time of check-in, and prior to being provided with camping credentials, the individual who made the reservation shall sign an Agreement to Waive Liability, Assume Risk and Indemnify.

Security and Personal Property

- EAA will have security present at Camp Scholler to monitor the campground, to enforce the Camping Rules and Policies, to provide assistance as appropriate, to help foster a safe environment and to report any incidents that may arise which require further action or attention.
- Campers are responsible for taking reasonable measures to protect their own safety and to safeguard and secure all items that they bring into Camp Scholler. Under no circumstances shall EAA be responsible for any personal property that is lost, damaged, or stolen.

Compliance with Laws, Disorderly Conduct, Drinking Alcoholic Beverages

- Campers must follow all federal, state and local laws, rules and regulations.
- Disorderly conduct, including drunken behavior, will not be tolerated.
- No one under the age of 21 may consume alcoholic beverages while on EAA property.
- Persons over the age of 21 who do drink alcohol must do so in a peaceful, respectful and nondisruptive way.

Relocation, Cancellations and Refunds

- EAA reserves the right, in its sole discretion, to relocate a camper to a different campsite within Camp Scholler if the campsite is unsuitable or use of the campsite may cause damage to the grounds.
- Reservation fees are not refundable for any reason.

Violations of Camping Rules and Policies

• Campers that violate any of the Camping Rules and Policies may be subject to removal from Camp Scholler with no refund for unused days provided.
